



Nominations open for The MIDORI Prize for Biodiversity 2016

Tokyo/Montreal, 15 February 2016– With the aim to encourage positive action for biodiversity and inspire others by showcasing the notable work of those it honours, nominations are now invited for the MIDORI Prize for Biodiversity 2016. The call for nominations remains open from 15 February to 30 June 2016.

The MIDORI Prize, a biennial international prize co-organized by the AEON Environmental Foundation and the Secretariat of the Convention on Biological Diversity (CBD), honours three individuals who have made outstanding contributions to the conservation and sustainable use of biodiversity.

Established by the AEON Environmental Foundation during the 2010 International Year of Biodiversity, this year marks the fourth time that the MIDORI Prize is being awarded.

Takuya Okada, Chairman of the AEON Environmental Foundation and Honorary Chairman of AEON Co., Ltd., said: "The conservation of biodiversity and the prevention of climate change are two of the greatest challenges of our time. We hope that the MIDORI Prize will contribute to meeting this global challenge, to the achievement of the Aichi Biodiversity Targets, and to the objectives of the United Nations Decade on Biodiversity 2011-2020."

Braulio Ferreira de Souza Dias, CBD Executive Secretary, said: "The MIDORI Prize, the unique international prize dedicated to biodiversity, by honouring the notable work of talented individuals, will contribute to raising public awareness on the essential role of biodiversity to humanity and to the objectives of the United Nations Decade on Biodiversity."

The Prize will be awarded at a special ceremony organized in conjunction with the thirteenth meeting of the Conference of the Parties to the CBD in Cancún, Mexico, in December 2016.

Establishment: The Prize was established by the AEON Environmental Foundation in 2010 to commemorate the International Year of Biodiversity, the tenth meeting of the Conference of the Parties to the Convention on Biological Diversity (CBD) in Nagoya, Japan, and the Foundation's 20th anniversary.

The Prize: The MIDORI Prize is awarded to three individuals who will each be honoured at an award ceremony held in conjunction with the thirteenth meeting of the Conference of the Parties to the CBD in Cancún, Mexico, in December 2016, and who will each receive a monetary prize of US\$100,000. The prize winners will be announced in October 2016.

AEON Environmental Foundation

Convention on Biological Diversity (CBD)

Opened for signature at the Earth Summit in Rio de Janeiro in 1992, and entering into force in December 1993, the Convention on Biological Diversity is an international treaty for the conservation of biodiversity, the sustainable use of the components of biodiversity and the equitable sharing of the benefits derived from the use of genetic resources. With 196 contracting Parties up to now, the Convention has near universal participation among countries. The Convention seeks to address all threats to biodiversity and ecosystem services, including threats from climate change, through scientific assessments, the development of tools, incentives and processes, the transfer of technologies and good practices and the full and active involvement of relevant stakeholders including indigenous and local communities, youth, NGOs, women and the business community. The Cartagena Protocol on Biosafety and the Nagoya Protocol on Access and Benefit Sharing are supplementary agreements to the Convention. The Cartagena Protocol, which entered into force on 11 September 2003, seeks to protect biological diversity from the potential risks posed by living modified organisms resulting from modern biotechnology. To date, 170 Parties have ratified the Cartagena Protocol. The Nagoya Protocol aims at sharing the benefits arising from the utilization of genetic resources in a fair and equitable way, including by appropriate access to genetic resources and by appropriate transfer of relevant technologies. It entered into force on 12 October 2014 and to date has been ratified by 70 Parties. For more information visit: www.cbd.int.
