- Current policy framework for EU development cooperation since May 2011
- Target and concentrate aid to where it is most needed and where it can make a difference
- Develop innovative ways of financing development
- Search for a greater alignment with partner countries' policies.





Change



Focus on Priority Areas:

• Human rights, democracy and governance:

 \rightarrow support to governance reforms that promote the sustainable and transparent management of natural resources.

Sustainable and inclusive growth for human development

 \rightarrow sustainable agriculture and energy that includes the safeguarding of ecosystem services and food and nutrition security.

→ business environment, regional integration, global market, social protection, health, education, job creation)







- "Development is not sustainable if it damages the environment, biodiversity and natural resources and increases the exposure/vulnerability to natural disasters."
- "EU development policy should promote a 'green' economy that can generate growth, create jobs and help reduce poverty by valuing and investing in natural capital."







Biodiversity Strategic Plan 2011-2020

- 20 Biodiversity Aichi Targets
- \rightarrow EU Biodiversity Strategy to 2020
 - 6 Targets, 20 Actions
 - International Dimension: Target 6: "Step up EU contribution to averting global biodiversity loss".
- Resource mobilisation strategy

→ International target: "to double financial flows for developing countries by 2015 and maintain until 2020"

B4LIfe

- Post-2015 Development Framework
- → "Development" and "Sustainable Development" processes converge
- \rightarrow New set of "Sustainable Development Goals"
- → Two biodiversity-specific SDGs + great opportunity for mainstreaming biodiversity in "non-biodiversity issues".
- → Claims for further integration and synergies among MEAs and simplifying SD arquitecture.



The instruments



- Bulk of the Dev.Coop. resources:
 - EDF (~€ 30,000 M) + DCI (~€ 20,000 M) + ENI (~€ 15,000 M)
- DCI thematic: € 7,000 M, of which:
 - Civil Society & Local Authorities: € 1,900 M
 - Global Public Goods and Challenges (GPGC): € 5,100 M
- GPGC shared in 5 priority areas:
 - Environment and Climate Change $\rightarrow \in 1,300 \text{ M} = 2.15\%$
 - and other four: Sustainable Energy; Food and Nutrition Security; Human Development; Migration and Asylum.
- Need for enhancing and mainstreaming across other instruments, programmes and policies, through 'Flagship Initiatives'

A Flagship ?





- More holistic and coherent approach of the EU actions in biodiversity:
 - \rightarrow clear and coherent strategic framework
 - \rightarrow enhance EU contributions to biodiversity
 - \rightarrow building new alliances with stakeholders
 - \rightarrow test innovative approaches and tools
 - \rightarrow more assertive integration of biodiversity in country policy dialogues
- More visibility, more prominence, enhanced profile for biodiversity within the development agenda, thus... more resources.

"Contribute to halting biodiversity loss and reducing poverty by promoting a cross-cutting and innovative approach to fully integrate biodiversity and ecosystem conservation with socio-economic development and poverty eradication".

- Four priority areas, in line with the **Agenda for Change**:

 - 2. Food security
 - 3. Green economy
 - 4. Wildlife Crisis





The Strategic Approach: Larger than elephants

Identify at the scale of Sub-Saharan Africa the principal threats to wildlife (animals and plants) and the most appropriate responses for the next 10 years.

European Commission

- Not limited to wildlife trafficking, but focused on conservation and sustainable management of wildlife and its linkage with development.
- Important for the aid programming
- Not limited to EU activities but can be a frame for many sources of funding
- Reviewed and endorsed by a wide array of stakeholders from the conservation community.

- > Jan 2014: **EP Resolution** on wildlife crime
- Feb 2014: Commission Communication on the EU approach against Wildlife Trafficking
- April 2014: EU on-line consultation and conference 170 experts, 34 countries, key IOs, >20 NGOs. Summary of contributions to the consultation published in Nov 2014.
- Feb 2014: London Declaration; Jun 2014: UNEA Resolution; Mar 2015: Kasane Statement.
- April 2015: *Joint Declaration of EU and AU Commissioners* mentions cooperation on illegal wildlife trafficking .



Regional and national political dialogues under Art. 8 of the Cotonou Agreement: wildlife conversation and wildlife crime increasingly addressed to tackle both the supply and demand side.

July 2015: **UNGA Resolution** on Illegal Wildlife Trafficking

Toward an Action Plan





- EU Action Plan on Wildlife trafficking in preparation by Commission (ENV, DEVCO, HOME, JUST, EEAS...).
- Based on strong support from stakeholders while the consultation.
- EUROPEAID provides input to this Action Plan on the development aspects, through its 'Larger than Elephants' report.
- Adoption hoped for 3 March 2016 (international wildlife day)
