

- Strategic Plan for Biodiversity 2011-2020 and its Aichi Biodiversity Targets adopted in 2010 in Nagoya
  - Vision: Living in harmony with nature by 2050
  - Mission: Halt loss of biodiversity to ensure that ecosystems are resilient and continue to provide essential services for human well-being
- 2030 Agenda for Sustainable Development and SDGs adopted in 2015.
- The Strategic Plan consistent with the 2030 Agenda and the SDGs




## Aichi Biodiversity Targets and the Sustainable Development Goals

## COP 12 Decision XII/4


 Requests the Secretariat to support Parties to ensure the appropriate integration of biodiversity
 2030 Agenda for Sustainable Development and SD Aichi Biodiversity Targets and the SDGs



## COP 13 Decision XIII/3:

- •Invites Parties to:
  - Take measures to reinforce synergies and integrated, coherent and mutually supportive implementation of the SPfB 2011-2020 and the 2030 Agenda for SD and other instruments: Paris Agreement, Sendai Framework for Disaster Risk Reduction, SAMOA Pathway, etc.
  - Mainstream biodiversity in the implementation of all relevant SDGs and relevant processes,
- •Requests the Secretariat to continue to support Parties in their efforts pursuant to the above

## CBD Secretariat's CB Role



Facilitation, coordination and reporting roles:

- Support implementation of the short-term CB action plan and the CB strategic frameworks for the Nagoya and Cartagena Protocols
- Foster partnerships, coordination, collaboration and networking in delivery of CD
- •Facilitate communication and exchange of information on CB activities/ achievements (e.g. through the BioCAP e-newsletter, CB web portal)
- Strengthen implementation support mechanisms
- Monitoring, reporting and review of implementation

## SCBD's Capacity-Building Support Role

- Strengthen implementation support mechanisms:
  - Support for NBSAP development / implementation (JBF)
  - Resource mobilization SCBD-BIOFIN Regional Support Nodes
  - Capacity-building short-term action plan, NP | CPB frameworks
  - Technical & scientific cooperation, e.g. through BBI, CSP support
  - CHM (central & national) Bioland tool, regional trainings
  - ABS Clearing-House and BCH capacity-building support
  - Cooperation and partnerships support Rio and Biodiversityrelated conventions, MoCs with various partners
- Review of implementation:
  - Biodiversity monitoring and indicators
  - National reporting trainings and help desk support
  - Review of implementation Voluntary Peer Review

# SCBD's Capacity-Building Support

- CB support for SPfB implementation and Aichi Targets:
  - Regional support networks for achievement of Target 11
  - GTI training-of-trainers programme on use of DNA technologies for rapid species identification
  - SCBD-IDLO training courses on ABS legal frameworks
  - Sustainable Oceans Initiative capacity-building programme
  - Forest Ecosystem Restoration Initiative
  - Regional dialogues and learning missions on climate change and biodiversity
  - Trainings on mainstreaming gender into NBSAPs
  - Support to the Global Youth Biodiversity Network activities

# SCBD's Capacity-Building Approaches

#### SCBD is applying a diverse range of CB approaches:

- •Training-of-trainers approach—e.g. GTI courses on use of DNA technologies for species identification
- •E-Learning approach Biodiversity e-Learning Platform (<a href="https://scbd.unssc.org">https://scbd.unssc.org</a>)
- •Blended learning approach e.g. SCBD-IDLO courses on ABS legal frameworks
- •Pilot and demonstration projects e.g. biosafety mainstreaming
- •Dialogues and learning missions e.g. climate change and biodiversity missions
- •Help desk support e.g. ABS Clearing-House virtual support
- •Global and regional support networks e.g. Protected area support networks, SCBD-BIOFIN support nodes, SCBD-IDLO ABS Legal Experts Network, and Global Youth Biodiversity Network
- •Development of support tools e.g. Bioland, Aichi Target poster tool, decision-tracking tool, etc.
- Experiential learning through internships at the Secretariat

## Post-2020 CB Framework

### COP 13 requested ES to:

- •Initiate a process for preparing a long-term strategic framework for capacity-building beyond 2020 (Decision XIII/23, paragraphs 15(m) and 15(n))
- •Prepare terms of reference for a study to provide the knowledge base to support the preparation of that strategic framework
- •Elements of the above process and TOR for the study have been proposed in document CBD/SBI/2/9 for consideration by SBI 2
