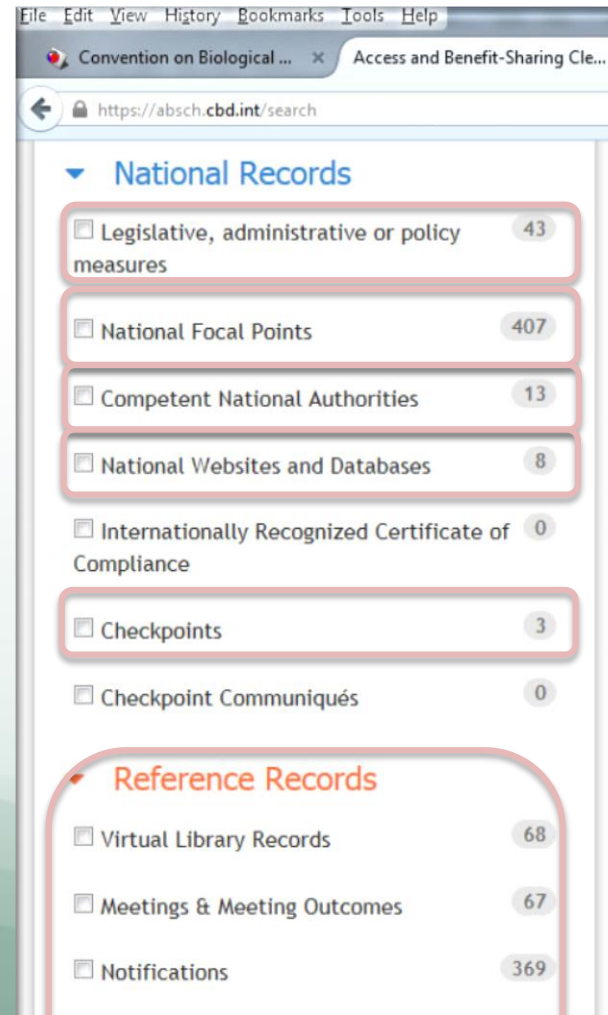
ABS-CH: What does it stand for?

- ABS-CH = Access and Benefit Sharing Clearing-House
- Based on article 14 of the Nagoya Protocol
- Information sharing on:
 - (a) Legislative, administrative and policy measures
 - (b) Information on the national focal point and competent national authority or authorities; and
 - (c) Permits or their equivalent issued at the time of access as evidence of the decision to grant prior informed consent and of the establishment of mutually agreed terms.

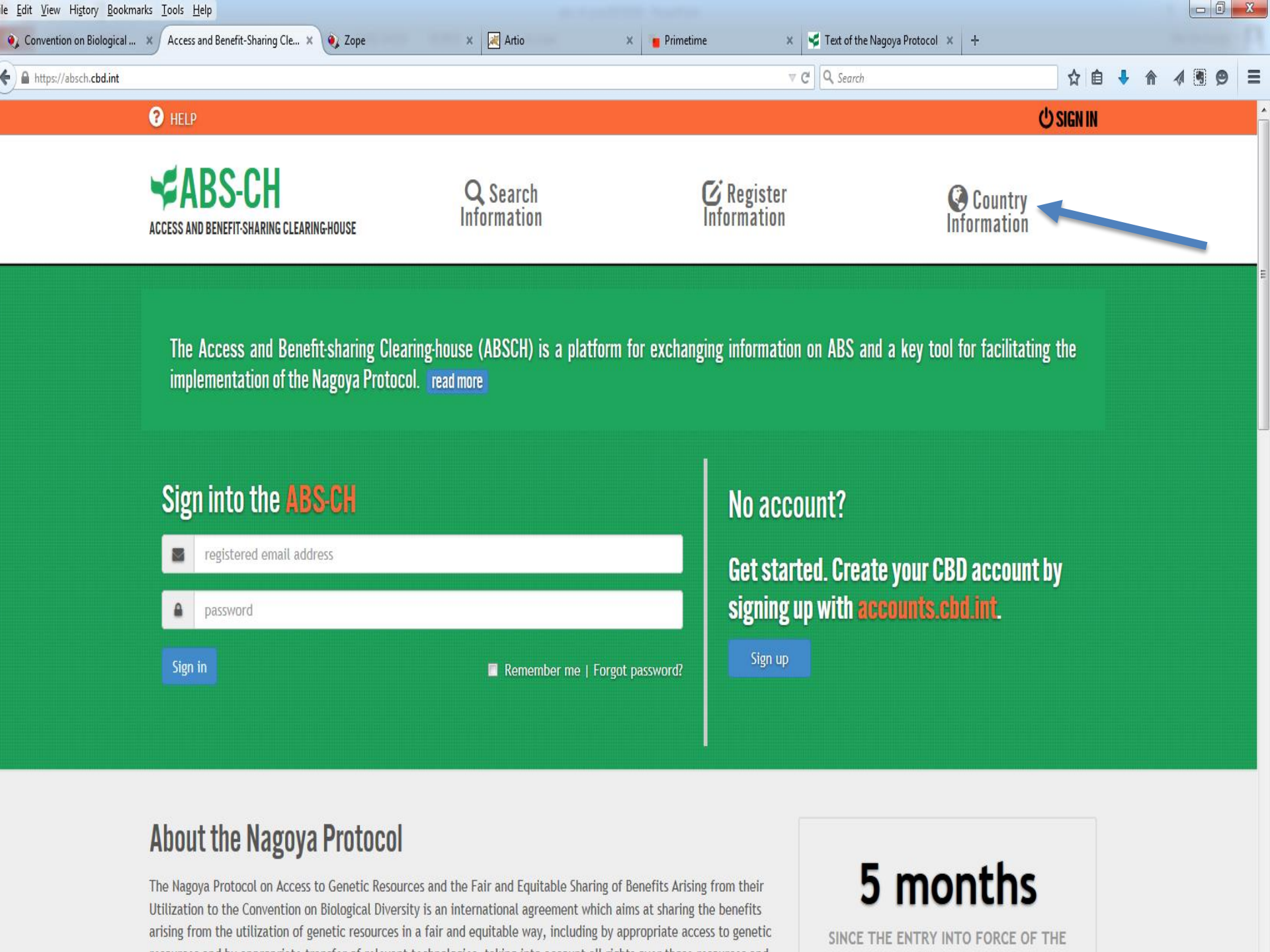
Why use ABS-CH?

- To organize collection missions taking into account the Protocol
- When receiving material with request for taxonomic identification
- Foreign student researcher (for example Indian) who brings genetic resources along
- To add link to the international recognised certificate of compliance to collection database

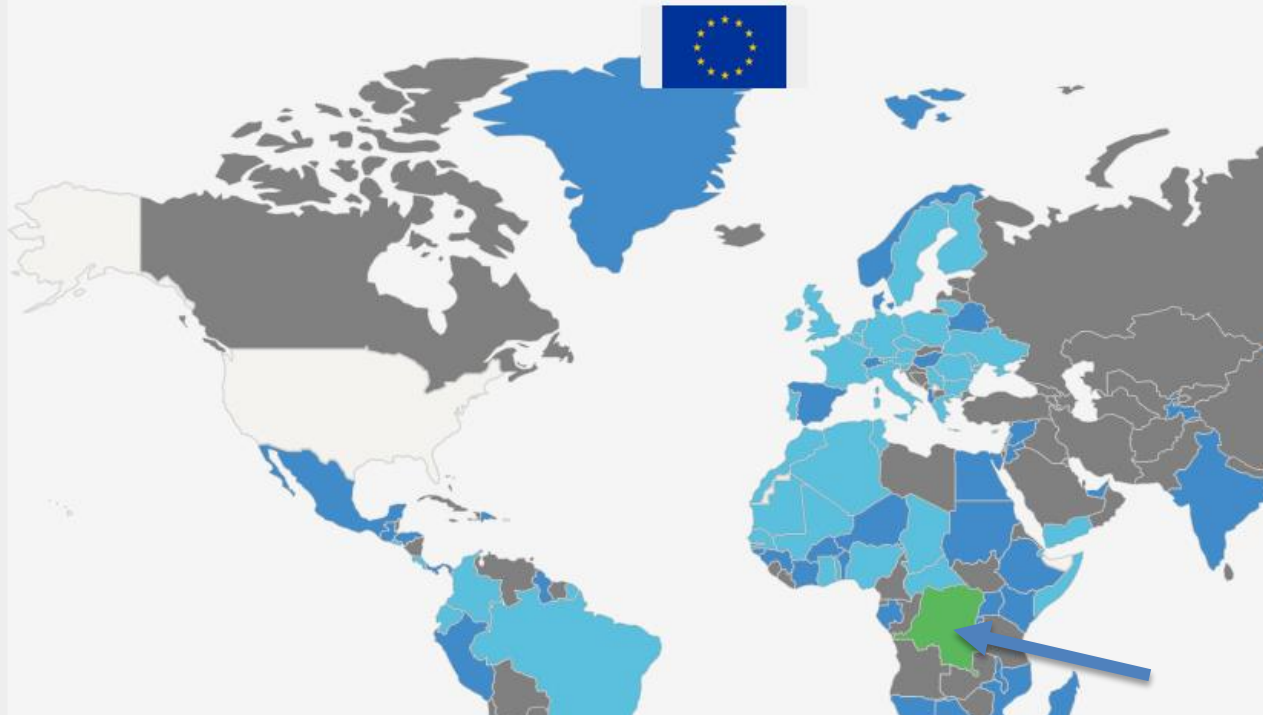

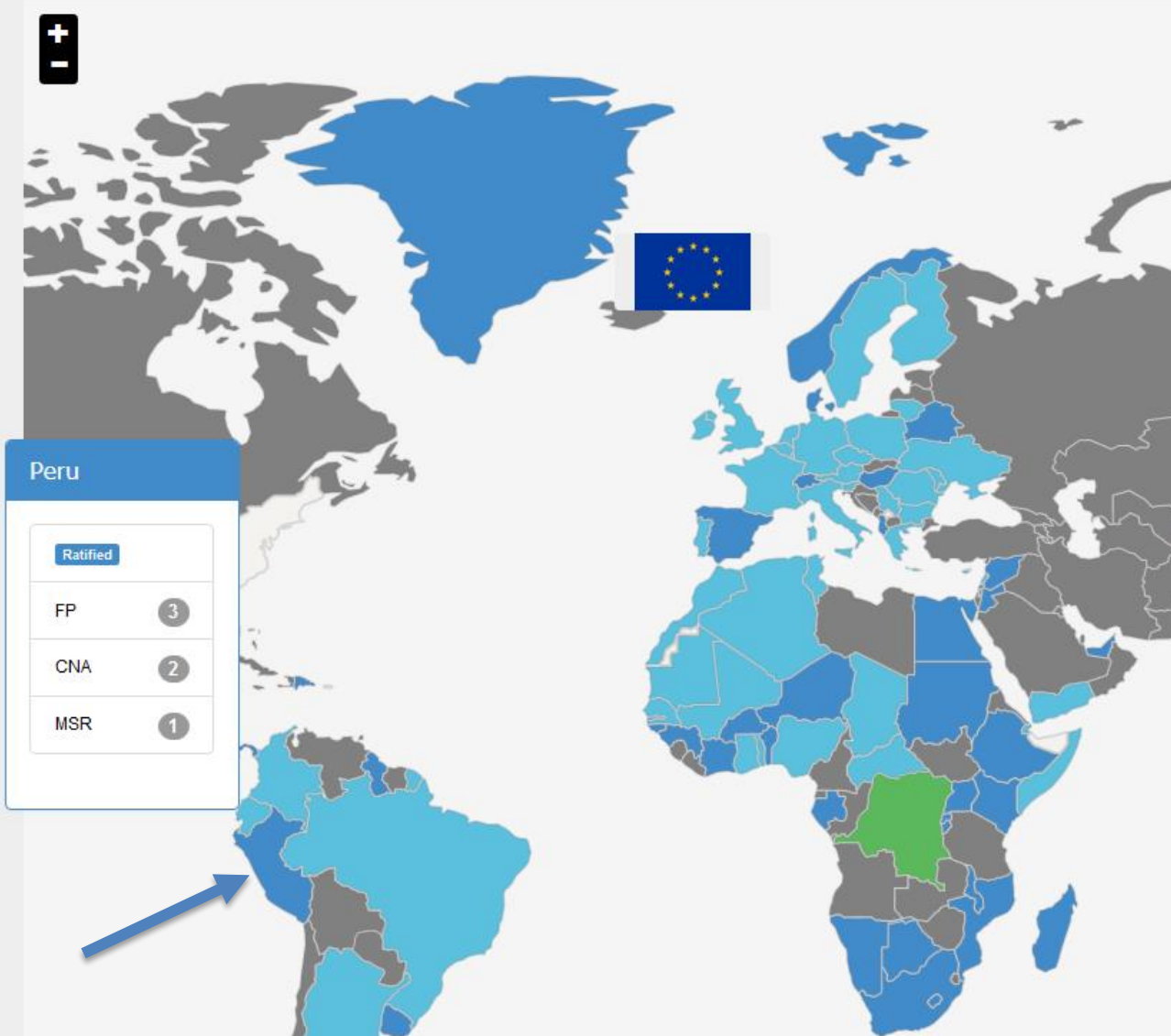
